FIRST ORDER OF BUSINESS

Call to Order

Ms. Syvret called the meeting to order and conducted roll call.

Ms. Syvret stated for the record that prior to the onset of the meeting, Leigh Simmons of Lee County Division of Natural Resources provided a presentation regarding watershed protection.

SECOND ORDER OF BUSINESS

Public Comment

Ms. Syvret opened the floor for public comment. There was none.

THIRD ORDER OF BUSINESS

Consideration of the Minutes of the Board of Supervisors' Meeting held on May 21, 2014

Ms. Syvret presented the minutes of the Board of Supervisors' Meeting held on May 21, 2014. She asked if there were any revisions to the minutes. There were none.

On a Motion by Mr. Sherman, seconded by Mr. Bonito, with all in favor, the Board approved the Minutes of the Board of Supervisors' Meeting held on May 21, 2014, for the Catalina at Winkler Preserve Community Development District.

FOURTH ORDER OF BUSINESS

Consideration of the Operations and Maintenance Expenditures for the Months of May, June, and July 2014

Ms. Syvret presented the operations and maintenance expenditures for the period of May 1-31, 2014 which total \$25,224.96, the period of June 1-30, 2014 which total \$68,725.73, and the period of July 1-31, 2014 which total \$17,883.81. She asked if there were any questions. There were none.

On a Motion by Mr. Sherman, seconded by Mr. Johnston, with all in favor, the Board approved the Operations and Maintenance Expenditures for the Months of May, June, and July 2014, for the Catalina at Winkler Preserve Community Development District.

FIFTH ORDER OF BUSINESS

Public Hearing Related to Adoption of the Final Budget for Fiscal Year 2014/2015

Mr. Bowen provided an overview of the process for the public hearings to be conducted related to the fiscal year 2014/2015 budget and assessments. He then asked for a motion to open the public hearing related to the budget.

On a Motion by Mr. Kirkbride, seconded by Mr. Sherman, with all in favor, the Board opened the Public Hearing related to the Fiscal Year 2014/2015 Final Budget, for the Catalina at Winkler Preserve Community Development District.

Questions and comments from the audience were entertained concerning the budget for fiscal year 2014/2015.

On a Motion by Mr. Sherman, seconded by Mr. Bonito, with all in favor, the Board closed the Public Hearing related to the Fiscal Year 2014/2015 Final Budget, for the Catalina at Winkler Preserve Community Development District.

SIXTH ORDER OF BUSINESS

Consideration of Resolution 2014-06, Annual Appropriations and Adopting the Final Budget for Fiscal Year 2014/2015

Ms. Syvret provided an overview of the Resolution, advising that adoption of the Resolution would effectively adopt the final budget for Fiscal Year 2014/2015.

On a Motion by Mr. Kirkbride, seconded by Mr. Johnston, with all in favor, the Board adopted Resolution 2014-06, Annual Appropriations and Adopting the Final Budget for Fiscal Year 2014/2015 as presented, for the Catalina at Winkler Preserve Community Development District.

SEVENTH ORDER OF BUSINESS

Public Hearing Related to Imposition of Assessments and Providing for Collection of the Same

Mr. Bowen asked for a motion to open the public hearing related to the assessments.

On a Motion by Mr. Sherman, seconded by Mr. Ratz, with all in favor, the Board opened the Public Hearing related to the Fiscal Year 2014/2015 Assessments, for the Catalina at Winkler Preserve Community Development District.

Questions and comments from the audience were entertained concerning the assessments for fiscal year 2014/2015.

On a Motion by Mr. Sherman, seconded by Mr. Kirkbride, with all in favor, the Board closed the Public Hearing related to the Fiscal Year 2014/2015 Assessments, for the Catalina at Winkler Preserve Community Development District.

EIGHTH ORDER OF BUSINESS

Consideration of Resolution 2014-07, Imposing Assessments and Providing for Collection of the Same

Ms. Syvret provided an overview of the Resolution, and asked if there were any questions. Mr. Bowen asked Ms. Syvret to confirm that the benefits received are greater than the assessment being imposed and that the assessment is fair and reasonable. Ms. Syvret confirmed, advised that the assessments are consistent with the District's assessment methodology, of which has been previously determined to be a fair and reasonable manner of allocating and imposing the assessments.

On a Motion by Mr. Sherman, seconded by Mr. Bonito, with all in favor, the Board adopted Resolution 2014-07, Imposing Assessments and Providing for the Collection of the Same, for the Catalina at Winkler Preserve Community Development District.

NINTH ORDER OF BUSINESS

Presentation Concerning Request for Partial Easement Vacation at Lot 72

Ms. Fountain of J.R. Evans Engineering provided an overview of the request for partial easement vacation at lot 72, advising the property owner would like to extend their lanai to accommodate a pool deck. They are requesting a 5 foot partial vacation of the drainage easement at the rear of the property.

Mr. Kayne noted that in the letter provided by Ms. Fountain, it is implied that a rear yard drainage pipe that will connect to the existing inlet at the northeast property corner, but the plan does not show the pipe. He also noted the plans show a four foot easement vacation, but a five foot easement vacation is being requested. Discussion ensued. It was noted that this request varies from the previous requests considered by the Board, as an additional foot of the easement

is requested to be vacated. Mr. Ratz advised he is considered whether with that additional foot will impact the ability to maintain a proper berm. Discussion ensued. It was determined that the engineer should revisit the plans and come back with revised plans that address the Board's concerns.

On a Motion by Mr. Kirkbride, seconded by Mr. Johnston, with all in favor, the Board tabled this item until the next meeting, for the Catalina at Winkler Preserve Community Development District.

TENTH ORDER OF BUSINESS

Discussion Concerning Proposals for Lake Maintenance

Ms. Syvret provided an overview of the responses she received related to the questions the Board had in regards to the proposals for lake maintenance. Discussion ensued.

On a Motion by Mr. Kirkbride, seconded by Mr. Johnston, with all in favor, the Board accepted the proposal from Lake Masters, and directed Staff to terminate the existing contract with Allstate Resource Management, for Lake Maintenance Services, for the Catalina at Winkler Preserve Community Development District.

The Board requested that the new vendor notify the District when they are coming to treat the lakes and to provide detailed reports for each visit.

ELEVENTH ORDER OF BUSINESS

Consideration of Audit for Fiscal Year End September 30, 2013 as Prepared by Grau & Associates

Ms. Syvret provided an overview of the audit for Fiscal Year end September 30, 2013 as prepared by Grau & Associates. She asked if there were any questions. There were none.

On a Motion by Mr. Sherman, seconded by Mr. Bonito, with all in favor, the Board accepted the Audit for Fiscal Year End September 30, 2013 as Prepared by Grau & Associates, for the Catalina at Winkler Preserve Community Development District.

TWELFTH ORDER OF BUSINESS

Appointment of an Audit Committee and Setting the First Meeting of the Committee

Ms. Syvret advised the audit for the current year is the final audit included in the current contract for auditing services. She further advised the Board would need to select an audit committee and set the first meeting of the committee to ensure an auditor is in place for the next fiscal year audit.

On a Motion by Mr. Sherman, seconded by Mr. Johnston, with all in favor, the Board appointed the Entire Board of Supervisors to the Audit Committee and Set the First Meeting of the Audit Committee for 3:30 p.m. on November 19, 2014, to be held at the office of Rizzetta & Company, Inc., located at 9530 Marketplace Road, Suite 206, Fort Myers, Florida 33912, for the Catalina at Winkler Preserve Community Development District.

THITEENTH ORDER OF BUSINESS

Consideration of Resolution 2014-04, Declaring Vacancies in Certain Seats on the Board of Supervisors

Mr. Bowen advised that the qualifying period for persons interested in seeking a seat on the Board has expired and no one qualified for the two seats up for election; Seat 3 currently held by James Ratz, and Seat 4 currently held by Richard Bonito. As a result he has a Resolution for consideration by the Board which declares those seats vacant as of November 18, 2014. He further advised the incumbent Board members shall remain in office until such time as the Board nominates qualified electors of the District to fill the seats. Discussion ensued.

On a Motion by Mr. Kirkbride, seconded by Mr. Sherman, with all in favor, the Board adopted Resolution 2014-04, Declaring Vacancies in Certain Seats on the Board of Supervisors, for the Catalina at Winkler Preserve Community Development District.

Consideration of Resolution 2014-05, Setting a Meeting Schedule for Fiscal Year 2014/2015
