FIRST ORDER OF BUSINESS

Call to Order

Ms. Blandon called the meeting to order and conducted roll call.

SECOND ORDER OF BUSINESS

Public Comment

Ms. Blandon stated for the record that no members of the public were present.

THIRD ORDER OF BUSINESS

Consideration of the Minutes of the Board of Supervisors' Meeting held on August 9, 2016

Ms. Blandon presented the minutes of the Board of Supervisors' Meeting held on August 9, 2016 and asked if there were any additions, deletions, or revisions to the minutes. There were none.

FOURTH ORDER OF BUSINESS

Consideration of the Operations and Maintenance Expenditures for the Months of July, August, and September 2016

Ms. Blandon presented the expenditures for the months of July, August, and September 2016. She asked if there were any questions regarding any item of expenditure. There were none.

FIFTH ORDER OF BUSINESS

Ratification of Previously Executed Insurance Proposal for Fiscal Year 2016/2017

Ms. Blandon provided an overview of the insurance renewal proposal, and advised it was executed outside of a meeting to ensure coverage began with the new fiscal year.

SIXTH ORDER OF BUSINESS

Ratification of Previously Executed Barraco & Associates, Inc. Proposal for NPDES MS4 Permit, Year 5 Annual Report

Ms. Blandon presented the proposal and advised the total fees are \$8,000. Mr. Kirkbride inquired as to the language in item #10. Ms. Whelan explained the statutes relative to the questioned language. Mr. Sherman also provided input.

SEVENTH ORDER OF BUSINESS

Ratification of Previously Executed Rizzetta & Company, Inc. Dissemination Agent Agreement

Ms. Blandon provided an overview of the agreement and advised Prager had resigned as Dissemination Agent for the District, so Rizzetta is taking on the contracts previously held by Prager, and honoring the same fee of \$1,000. Mr. Sherman inquired as to a conflict of interest. Ms. Whelan advised there is no conflict of interest.

EIGHTH ORDER OF BUSINESS

Consideration of Resolution 2017-01, Adopting Alternative Investment Guidelines

Ms. Blandon provided an overview of the resolution advising it is in accordance with Florida Statutes 218.415, the District is required to adopt an alternative investment policy. This is for the investment of public funds in excess of the amounts needed to meet current expenses.

On a Motion by Mr. Sherman, seconded by Mr. Sanchez, with all in favor, the Board adopted Resolution 2017-01, Adopting Alternative Investment Guidelines, for the Catalina at Winkler Preserve Community Development District.

NINTH ORDER OF BUSINESS

Consideration of Resolution 2017-02, Redesignating Treasurer of the District

Ms. Blandon advised Mr. Joe Kennedy has resigned from Rizzetta & Company and it is appropriate to redesignate the Treasurer.

On a Motion by Mr. Sherman, seconded by Mr. Bonito, with all in favor, the Board adopted Resolution 2017-02, Redesignating Mr. William Rizzetta as Treasurer of the District, to Replace Mr. Joe Kennedy, for the Catalina at Winkler Preserve Community Development District.

TENTH ORDER OF BUSINESS

Review and Consideration of Prompt Payment Policies and Procedures, Resolution 2017-03

Ms. Blandon advised the memo was received from Counsel on September 9, 2016. Mr. Sherman inquired if there were issues which caused the passing of this resolution. Ms Whelan explained the resolution and process, advising the policy reiterates the statutory timeline for payment of invoices and creates procedures for handling payment disputes.

On a Motion by Mr. Kirkbride, seconded by Mr. Johnston, with all in favor, the Board Adopted Resolution 2017-03, Prompt Payment Policies and Procedures, for the Catalina at Winkler Preserve Community Development District.

ELEVENTH ORDER OF BUSINESS

Staff Reports

A. District CounselMs. Whelan advised she had no further report.

B. District Engineer

Mr. Kayne advised the draft report for Cycle 4 is available for review, and if there are no significant changes, he will move forward with the report. Mr. Sherman asked if there was anything the Board should be aware of on testing changes. Mr. Kayne advised of fecal matter testing due to septic systems and wading birds. He advised pet waste stations in these cases are recommended. Mr. Kayne advised Catalina does have a SFWMD permit, and perhaps notices should be sent to residents advising of what not to do. He further advised the District's vendors know of the fertilization requirements and are properly licensed, the concern is with homeowners who have their own vendors and ensuring those vendors maintain compliance.

C. District Manager

Ms. Blandon advised of a letter received from a resident concerning the preserve area and spraying and/or cutting within the preserve. Mr. Kayne commented on the preserve property line, outlining where it starts and ends.

On a Motion by Mr. Kirkbride, seconded by Mr. Sanchez, with all in favor, the Board directed Staff to obtain Preserve Maintenance Proposals, and provided authorization to the Chairman to Executed the Appropriate Contract, for the Catalina at Winkler Preserve Community Development District.

Ms. Blandon announced that the next meeting of the Board of Supervisors is scheduled for Tuesday, February 14, 2017 at 2:30pm.

Supervisor Requests and Comments

Ms. Blandon opened the floor to Supervisor requests and comments.

Mr. Sherman discussed the need for additional alligator signs; he further advised that some residents had issues with the signs, they agreed with the wording of the signs but were concerned with the aesthetics of the signage. Discussion ensued regarding moving the signs.

Discussion ensued regarding restoration on the middle lake bank. Mr. Kayne advised he will look into the preparation work that may have been completed by his firm.

Discussion ensued regarding the appointment of three Board members to fill the seats declared vacant as of November 22, 2016.
